The Ghana Grid Company Limited (GRIDCo) has received financing from the European Union (EU) through the Agence Française de Développement (AFD), and intends to use part of the funds thereof for payments under the following project; *Project Management and Supervision for the 161kV Ahodwo (K1BSP)- Anwomaso (K2BSP) Transmission Line Upgrade Project.*

The services of the consultant shall consist of assisting the Project Implementation Unit of the GRIDCo in the overall project implementation covering Resettlement Action Plan (RAP) implementation, project management and contract administration, engineering and construction supervision, environmental and social monitoring and specific training for client staff on the 161kV Ahodwo (K1BSP) - Anwomaso (K2BSP) Transmission Line Upgrade Project.

GRIDCo hereby invites Applicants to show their interest in delivering the Services described above. This Request for Expressions of Interest is open to:

Eligibility criteria to AFD financing are specified in sub-clause 1.3 of the "Procurement Guidelines for AFD-Financed Contracts in Foreign Countries", available online on AFD's website: <http://www.afd.fr>.

The Applicant shall submit only one application, either in its own name or as a member of a Joint Venture (JV). If an Applicant (including any JV member) submits or participates in more than one application, those applications shall be all rejected. However, the same Subconsultant may participate in several applications.

If the Applicant is a JV, the expression of interest shall include:

- a copy of the JV Agreement entered into by all members, or
- a letter of intent to execute a JV Agreement, signed by all members together with a copy of the Agreement proposal,

In the absence of this document, the other members will be considered as Subconsultants.

Experiences and qualifications of Subconsultants are not taken into account in the evaluation of the applications.

Interested Applicants must provide information evidencing that they are qualified and experienced to perform those services. For that purpose, documented evidence of recent and similar services shall be submitted.

Determination of the similarity of the experiences will be based on:

- The contracts size
- The nature of the services provided

- The technical area and expertise
- The location [*Sub Saharan African*]

The Client will also take into account for the evaluation of the applications the following items:

- Skills and availability of in-house technical back-up experts provided to the on-site experts
- Local representatives/partners
- Quality assurance procedures and certifications of the Applicant – such as ISO 9001 or equivalent
